SUBJECT: COVID-19 PRECAUTIONARY MEASURES: RESTRICTIONS ON NON-URGENT ELECTIVE ADMISSION, VISITORS AND VISITING HOURS, AND ATTENDANCE OF INTERNAL MEETINGS

In the continuous efforts of KFSH&RC to optimize precautionary measures against COVID-19, the following decisions are made:

1. Rescheduling of all non-urgent elective surgeries and procedures in consultations with the concerned departments and without an impact on outcome. The Patient Flow and Command Centre will facilitate this action.
2. Restrictions on the number of visitors and visiting hours.
 - The visitors are limited to close relatives and maximum two (2) patients' relatives only.
 - The visiting hours (including weekends) are scheduled as follows:
 - General Wards: 8:00 p.m. – 9:00 p.m.
 - All ICUs: 12:00 p.m. – 12:30 p.m.
 - 8:00 p.m. – 8:30 p.m.
 - Mother of neonates are exempted from the visiting hours' restrictions.
 - Outpatient visit companion should be limited to one (1) for adult and two (2) for children.
3. All Departments are requested to limit the attendance of internal meetings not more than fifty (50) persons.
4. All Departments are encouraged to utilize virtual meetings as much as possible.
